#### Dr. Thomas E. Caneva All-State Band Conductor

Thomas E. Caneva is Director of Bands, Professor of Music and Coordinator of Ensembles and Conducting at Ball State University. At Ball State, Caneva's responsibilities include conducting the Wind Ensemble, coordinating the graduate wind conducting program, teaching undergraduate conducting and administering the entire band program.

Since his arrival at Ball State in 2006, Dr. Caneva has conducted the Ball State University Wind Ensemble at the 2009 MENC North Central Division Convention, the 2010 CBDNA North Central Division Conference, the 2011 IMEA State Convention, the 2011 CBDNA National Conference in Seattle, Washington, and the 78<sup>th</sup> Annual Convention of the American Bandmasters Association in 2012.

In 2007, Dr. Caneva founded the Ball State University Wind Band Conducting Workshop, which has attracted many aspiring conductors from throughout the United States. An advocate of new repertoire for wind band, he has been a part of sixteen commission projects and premieres at Ball State. Additionally, he serves as the Concert Band Coordinator for the *Music for All* Summer Symposium.

Previous to his appointment at Ball State University, Dr. Caneva served on the faculties of the University of Illinois, University of Colorado, Auburn University and the University of Texas at Austin. His teaching career began at Lincoln-Way Community High School in New Lenox, Illinois.



In 2001, Dr. Caneva was elected to membership in the American Bandmasters Association. He currently serves as the Indiana State Chair of the College Band Director's National Association and has previously held offices in the National Band Association; the Big 12 Band Director's Association and is a past member of the Board of Directors of the Colorado Music Educators Association. Other honorary and professional affiliations include the National Association for Music Education, Indiana Bandmasters Association, Phi Kappa Phi, Pi Kappa Lambda, Phi Mu Alpha (honorary) and Kappa Kappa Psi (honorary).

Dr. Caneva received a Bachelor of Science in Music Education from the University of Illinois at Urbana-Champaign, a Master of Music in Wind Conducting from the University of Texas at Austin, and a Doctor of Musical Arts in Instrumental Conducting and Literature from the University of Colorado at Boulder.

#### Dr. Paul W. Popiel All-State Honor Band Conductor

Paul W. Popiel is the Director of Bands at the University of Kansas, only the seventh person to hold this position in the band's storied 125-year history. Dr. Popiel conducts the KU Wind Ensemble, directs the graduate program in wind conducting, and guides all aspects of the university band program. His previous appointments include the Indiana University Jacobs School of Music and Oklahoma State University. He also enjoyed six years teaching in the public schools of Texas and Michigan.



Dr. Popiel has lectured and performed throughout North America, Europe, Singapore, and Japan. He has produced several CDs for the Wind Band Classics series on the Naxos label, leading the KU Wind Ensemble on the latest Naxos project, "Landscapes", featuring the music of Michael Torke, Aaron Copland, and Frank Ticheli, which will be released in the Spring of 2013. A proponent of distinctive new music, Popiel has commissioned and premiered numerous new works for winds, including composers Michael Torke, Mohammed Fairouz, David Dzubay, and Kevin Walczyk. Popiel makes his Carnegie Hall debut in March 2013, leading the KU Wind Ensemble in the world premiere of Mohammed Fairouz's "Symphony Number 4: In the Shadow of No Towers".

Dr. Popiel holds degrees from Truman State University, the University of Notre Dame, and Michigan State University. A recipient of a Rotary International Ambassadorial Scholarship, he also earned a Postgraduate Diploma in Twentieth-Century Music at the University of Bristol, England. Dr. Popiel was the 2003 Frank L. Battisti

Conducting Fellow serving as the Resident Conductor of the Boston University Tanglewood Institute.

Paul, his wife Julie, and their two sons, Nicholas and Keith, live in Lawrence, Kansas.

# 2013 Indiana Gamma Chapter, Phi Beta Mu Outstanding Bandmaster James M. (Mike) Clark

Mike was born July 25, 1961, in Cincinnati, Ohio, to Danny M. and Wanda Joyce (Carew) Clark. The Clark family moved several times before settling in Somerset, Kentucky where Mike graduated from Somerset High School. He attended Western Kentucky University in Bowling Green, KY and earned his Bachelor of Arts in Music Education in May of 1985. On Dec. 28, 1985, Mike married his high school sweetheart, Traca Roback. Together they raised two beautiful daughters, Catherin (age 25) and Sarah (age 22). Mike went on to earn his Master's in Music from Indiana University – South Bend in 2000.

Mike was employed by the Southeastern School Corporation as the Lewis Cass High School Director of Bands from 2002 until his passing. He was band director at Wawasee High School from 1993-2002. While living in the Syracuse area, Mike served as Director of the Lake Area Community Band. He also taught at Whitko High School from 1986-1993. Mike was a member of Upper Deer Creek Church where he served as Deacon, taught Sunday school, and was a member of the Praise and Worship Team. Mike was an active member of Phi Beta Mu Professional Band Master's Fraternity. Mike was also an avid water skier, hunter and fisherman.

Mike battled his cancer for a period of seven years. Mike fell ill shortly before the 2005 Marching season and after State finals about 60 students conducted a driveway performance at his home. Mike said then, "It was a chance for them to show some unity. We try to stress life skills in our program." This was Mike Clark's strength and was always a teaching model to show a positive attitude no matter what the circumstances.



In early September 2012, the executive board and "Outstanding Bandmaster" nomination committee began correspondence for the Gamma Chapter's 2013 Outstanding Bandmaster Award. Our "Outstanding Bandmaster" Committee decided to present only one name for this year's award: Mike Clark. Mike had an outstanding career including 1 Class C State Marching Championship and 4 Class D State Marching Championships with the Lewis Cass Band. In addition, he was an inspirational teacher and member of his community. It was quickly decided that due to Mike's failing health (and the 6 week normal time frame to get the plaque) the Executive Board asked to do a quick poll of the membership to approve this action. Just days before he passed, this award was presented to Mike.

Don Krug had the following comments about Mike. "We have been so very grateful of the great lessons in courage, determination, and faith that Mr. Mike Clark has given us during the last year and the many previous years during all his cancer treatments and occurrences. He has always tried to do more than expected and given more than necessary. His ability to inspire our students is greater than any imagined possible. The first time the band went to contest with him, he asked the students to line up around the field on the outside of the side lines and end zone line. Then he asked them to take one step forward and open the new chapter of the Lewis Cass Marching Kings. We are still opening the new chapters. The legacy of the Marching Kings and the Lewis Cass bands will continue as long as we have the courage, determination, and faith that has been given each of us".

James M. (Mike) Clark, 51, of Walton, Ind. went to be with his Heavenly Father on Sunday, Sept. 30, 2012. Mike is survived by his wife: Traca; two daughters: Catherin Clark, and Sarah (Kitt) O'Brien; his parents: Danny M. and Joyce (Carew) Clark; a sister: Joyce Ann (Chris) Adkins; three brothers: Mark E. (Patty) Clark, Patrick W. (Martha) Clark, and W. Miles (Michelle) Clark; and several nieces and nephews.

## 2013 Indiana Gamma Chapter, Phi Beta Mu Hall of Fame Inductee Jon S. Sutton

A native of New Castle, Indiana, Jon S. Sutton began his musical career as a trumpet player in the New Castle High School Band. After high school he attended Ball State University where he received his BS and MA in music education. In 1973 he began his teaching career in Knightstown, Indiana where he taught for 4 years. In 1977 he accepted the band director position in Lebanon, Indiana where he remained for 5 years. Beginning in 1982 he spent the last 27 years of his career in Greenwood, Indiana where his bands were ranked among some of the best in the state.



His marching bands made 26 consecutive state finals appearances. Of those appearances, 22 were top 3 finishes with 10 of those being Class B State Championships. His concert bands received 25 consecutive gold ratings with 4 state finals appearances, his winter guard received 26 consecutive state finals appearances with 17 top 5 finishes and his winter percussion received 9 consecutive state finals appearances including 2 state championships. His organizations have performed in the Philadelphia Thanksgiving Day Parade, the Fiesta Bowl Field Competition and Parade, the Hollywood Christmas Parade, the 500 Festival Parade and the Smoky Mountain Music Festival.

Mr. Sutton has served as an adjudicator in Indiana, Kentucky, Tennessee, Arizona and Hawaii. He also serves as an adjudicator for the Indiana State School Music Association including adjudication of marching band, concert band and solo and ensemble festivals. He has served as guest conductor of the Purdue University Band Day, the Greater Greenwood Community Band and the Brown County Community Band.

He is past president of Gamma Chapter of Phi Beta Mu. He helped found the Greater Greenwood Community Band and served on the committee that built the City of Greenwood Amphitheater. He has served on the ISSMA State Board, Marching Band Committee and trained ISSMA solo and ensemble adjudicators. He has hosted ISSMA events including Solo and Ensemble Festival, Jazz Band Festival, Large Organization Festival and District Marching Band Festival. He has also hosted the Central Indiana Marching Band Festival and the Greenwood Marching Band Invitational.

Some of the recognition and honors received by Mr. Sutton include induction into Phi Beta Mu, 1997 Indiana Outstanding Bandmaster Award, Greenwood Chamber of Commerce Outstanding Educator Award, the City of Greenwood Citizen of the Year Award, named Greenwood Honorary Mayor and he was presented with the Key to the City of Greenwood. He and his wife, Peggy, were married in 1973 and are getting ready to celebrate their 40th anniversary. He enjoys travel, woodworking and is still actively involved in the band activity. Jon and his wife are active members of the Mt. Auburn United Methodist Church.



#### Phi Beta Mu

Phi Beta Mu is the highest honorary international band director's fraternity. It was organized to encourage the building of better bands and the development of better musicians in schools throughout the world and to foster deeper appreciation of good music and more wide spread public interest.

Phi Beta Mu was established as a result of the respect and appreciation its founder, Colonel Earl D. Irons, had for his professional associates, school band directors. He envisioned an organization that would honor outstanding band directors whose dedication and devotion to their profession was paramount, but whose admirable traits and services were not necessarily known nationally. In order to do this, Col. Irons sought to honor deserving individuals on a state level. The fraternity was named *Phi Beta Mu* with the subtitle *National Bandmasters Fraternity*, as the name of the organization. *Phi Beta Mu* was interpreted to mean *Life*, *Love*, *and Music*. The colors chosen to represent the Fraternity were blue and white.

The first official meeting was held at the Rice Hotel in Houston, Texas in February, 1939. The first initiates were R.C. Davidson, Jack H. Mahan, Lyle Skinner, Alfred Wiley, Vergne Adams, and Holmes McNeely. Dr. Cothburn O'Neal was the first individual to be made an Honorary Member in recognition of his work with Col. Irons in developing the Fraternity Constitution and Oath.

Dr. Milburn Carey was initiated in 1942 as a member of Alpha Chapter. In 1944, Dr. Carey chartered Beta Chapter in Enid, Oklahoma. In 1946, Harold L. Walters, who had become an honorary member of Beta Chapter, invited Dr. Carey to charter Gamma Chapter in Indiana.

Gamma Chapter of Phi Beta Mu was organized and the charter members initiated on November 27, 1953, at the state convention of the Indiana Music Educators Association. There are presently nearly 100 active members in the state of Indiana.

With an International Office, the Fraternity grew to include additional state chapters and began expanding into foreign countries. New chapters were established chapters in Graz, Austria and Alberta, Canada in 1975, and Japan in 1978. International growth continues today as Phi Beta Mu's ideals are recognized as valid and important to the development of bands throughout the world.

#### Phi Beta Mu is:

- The only national or international bandmasters' fraternity in the world;
- The only bandmaster-organization to be organized because of one's love and respect for his fellow man;
- The only bandmaster's organization that provides a forum, by oath, for a closer contact between leading members of the profession;
- The one organization that acts as a liaison between all bandmaster organizations; and
- The one organization which, through the American Bandmasters Association, has as its heritage the greatest bandmasters of all time.

#### **Indiana Bandmasters Association**

#### Dedicated to Better Indiana Bands

#### Purpose

- 1. To stimulate interest in the study of the band and its literature.
- 2. To develop a desire for good band literature.
- 3. To encourage good fellowship between the members of the Association.
- 4. To bring the work of the Association before the Indiana Department of Education and the citizens of the State in order that it shall gain greater recognition and support.
- 5. To provide educational meetings for band directors to raise the standards of instruction.
- 6. To secure recognition of School Administrators and Boards of Education to the effect that the band is an integral part of the school curriculum and is entitled to recognition as a curricular subject.
- 7. To develop a band in each community which shall serve as a vital force in bringing people into a closer relationship with the schools of the State.

#### History

Founded in 1953, the Indiana Bandmasters Association would initially engage in sponsoring a Marching Band Clinic, an All-State Band, and act in an advisory capacity for IMEA on band activities. The first Marching Band Clinic was organized in the fall of 1956 and continued each year through the summer of 1979. IBA would sponsor its first All-State Band in 1961 with John Paynter as the guest conductor. The event went to two ensembles, the All-State Band and the All-State Honor Band, in 1980. The first Junior High All-Region Bands were organized in the fall of 1980 at three sites. As interest grew the number of sites was increased to the current twelve. In 1994 the event was renamed the All-Region Honor Band Festival.

The first IBA commission was premiered at the 1988 All-State Honor Band concert with the composer, Robert Jager conducting. The Association premiered the first junior high commission by John O'Reilly at the All-Region Festivals later that fall. The winter of 1995 saw the first collaboration of the Indiana chapter of the College Band Director's National Association (CBDNA) and IBA to sponsor the Indiana All-Collegiate Honor Band. The group now is formed biannually to perform at the IMEA Professional Development Conference.

In 1999 IBA established a site on the World Wide Web (www). That year the Association also established All-District Honor Bands for students in grades nine through twelve, performing at six sites in the fall of 2000. The first All-District Band commission, by Robert Sheldon, was premiered in the fall of 2005. IBA now commissions a new work for concert band each school year.

In 2005, the membership of IBA established the "Ray Cramer Scholarship" a one thousand dollar grant to be awarded annually to a senior member of the All-State Bands who will pursue a career in music. Previous scholarship recipients are:

In 2009 IBA and IMEA co-sponsored the first Indiana Junior All-State Band for students in grades seven through nine. Their premier performance was held in conjunction with the 2009 IMEA State Convention. Dr. Susan Creasup from Morehead State University served as the first guest conductor. The group is now formed annually to perform at the IMEA Professional Development Conference.
